## Professional Overview

### GOVERNMENTAL PROJECTS

**State Convention Center.** Land use counsel for the construction of the state convention center over I-5 in Seattle and the subsequent convention center expansion project, which included an exhibit hall, an office building, the Elliott Hotel and public atrium beneath a glass canopy arching over Pike Street. The projects involved City departmental approvals, Hearing Examiner hearings, City Council approvals, street vacations, conditional uses, rezoning, and transferable development rights (TDRs) agreements.

**University of Washington.** Land use counsel to the University of Washington in the development of its downtown Metropolitan Tract and in the development of its master plans (1990 - 2000, 2001 - 2010, and 2015 - ongoing), which approved an unprecedented building program for new science and bio-tech facilities on its main campus.
